It is proposed to fill up One Post of Technician (T-1)& One post of Technical Assistant (T-3)(ONE)-Category-II under the Functional Group of **Information & Technology/Computer** as per the Notification dated 27.11.2025 (enclosed) by Inter-Institutional transfer basis from amongst the Technical personnel from all Institutes' of ICAR having completed minimum tenure of five years of regular service after initial appointment on the crucial date of eligibility i.e. as 28.11.2025.
2. The candidates must be initially appointed as Technician (T-1) & Technical Assistant (T-3)-Category-II under the Functional Group as mentioned in the Notification may send their applications through proper channel in the enclosed proforma (format of application) to the undersigned.

For Category-I the candidate must possess qualification Matriculation pass or equivalent from a recognized Board as per the Council Lr. No.19(13)/2015-Estt.IV, dated 8.12.2015 or as amended from time to time by the Council.

For Category-II the candidate must possess essential qualification i.e. bachelor's degree in agriculture or equivalent qualifications from a recognized University.

The last date of receipt of applications is 26.12.2025. Applications received after the last date or otherwise incomplete are not likely to be considered. The Selection Committee/the Director, ICAR-ATARI,Zone-VII, Umiam (Barapani), Meghalaya, however, will reserve the right to accept/reject the applications without assigning reason thereof.

3. In case of applications received in large numbers, criteria shall be formulated for selecting the candidate for the above said vacancies in different functional groups.
